Discussed information for tax letter to be inserted with tax bills

Route to Recovery grant discussed and decided on election costs, Genoa Fire Department, getting ahold of Jerry Pedretti to discuss.

Paying Charlie Gartner for 3 months of wages for 3 months, up to the time of his death.

Patrolman position to be parttime to help through the winter months when needed or on call. No posting at this time.

Several names mentioned. Need to get in contact with them. Suggested \$15/hr.

Received a bid from Johnston Refrigeration for new heater for the shop. Tabled to then next meeting. Working at this time.

Talk to Dean Goede to take the old Discbine mower to Sweeneys

Discussed purchasing a tractor and brush mower from Simpson's in Richland Center for \$32,500. Keith to contact them about it and possible financing.

Discussed getting sand from Lepke's. Vikemyers not able to haul out of river yet. Don't want to wait too long. Motion made by Bauer/Wendorf to get from Lepke's, asking to have sand cleaned up removing weeds and trash before delivering. Motion carried

**Treasurer's Report:** Motion made and seconded by Bauer/Goede to approve the treasurers report and pay bills. Motion Carried.

**Clerks Report/Accounts Payables:** Payables were discussed. Pay all bills and the remaining bill to Scott's and pay out 1 week of vacation to Scotte Meyer with the leaving of Scott Lockington. Motion made and seconded by Bauer/Wendorf to pay all the bills. Motion Carried.

## **Zoning Report:**

Mark Kallenbach called Clerk Parr and addressed land to be vacated. She passed it on to Zoning Coordinator Strachan and he will contact him. He will check with surveyor to see if Township still owns the dirt road to cemetery.

Mendiola would like to rezone property, Pete to contact them.

Eli Miller requested a building permit. Motion made and seconded by Bauer/Goede. Motion carried.

Motion made and seconded by Wendorf/Bauer to go into closed session at 7:40 pm.


Board went into closed session
