Motion made and seconded by Goede/Bauer for Plaque of service in memory of Charlie Gartner to be made by Johnny Miller and materials to be donated by Kevin and Carolyn Parr. Motion carried

Opening of sealed bids for truck and engine. For the truck we had 4 bids and the motor we had 3 bids. Motion was made and seconded by Bauer/Goede to accept the bid of \$4,000 from Joe Simonson for the truck and \$925 for the motor from Randy Jasper. Bidders were notified and have paid and received items.

Motion made and seconded by Bauer/Wendorf park Snapper mower outside Town Hall with For Sale sign and sealed bids accepted. Motion carried
