Rudy Hochstetler would like to build a 250 commercial calf barn. Concerns from the Hofer's were because of the steep grade erosion pertaining to runoff to ponds, manure handling before and after crops are planted and stock piling, contaminating drinking water, washout with heavy rains. Motion was made and seconded by Kent/Lorn to approve with condition for the above concerns to be included in the approval letter mailed to neighbors. Any concerns can be addressed with Lorn if any come up. Motion carried.

Franciscan Congregation of Divine Mercy, Inc would like to have Animal Therapy available on the property to coach trauma therapy for children, adults and families. This would include using horses in a confined area. Only concern was will there be any overnight stays and Mother Mary said it would not. Motion made and seconded by Lorn/Kent to approve with no conditions. Motion carried.

Todd Whisler would like to get approval for a 20-year plan for a quarry on his property. Todd is working with the DNR. Concerns from neighbors are noise, pollution, dust, reduction in property values. DNR will approve the final quarry and Todd will have to follow their guidelines. Motion made and seconded by Lorn/Kent to approve with final approval from DNR. Motion carried.

Outbuilding permit for Andy U Miller and Dwelling for Melvin Miller. Motion made and seconded by Lorn/Kent to approve building permits. Motion carried.


Town Roads


