Vernon County has contracted again this year with a mailing company to produce and distribute tax bills for their Townships.

You will still make payments to Town of Harmony, **the tax roll copies will be available at Sorenson Lane, Town Hall, or online.**

Please mail payment to the address on the tax bill payable to the Town of Harmony or drop it in the locked drop box at the Town Hall, E2905 Newton Road.

If you are going to claim your taxes in 2020, payment must be mailed by December 31, 2020- otherwise payment must be made by January 31, 2021 to be considered timely by the county. Please make sure you pay the Correct Amount due. Assessment questions need to be directed to Barrett Brenner and errors need to be addressed at the County Treasurer's office at 608-637-5367. I can only correct addresses if you made corrections on tax bill.

Dog license fee may be mailed with tax payments, but must be Paid by separate check to Town of Harmony. DOG LICENSE-Due by January 31 ,2021. Male \$8.00; Neutered \$3.00, Female \$8.00; Spayed \$3.00, Kennel licenses are \$35.00. Please enclose your current Rabies Certificate of Vaccination (NOT AN INVOICE), or I can't issue a license.

The Town Recycling Center is open every TUESDAY 3:00 pm – 7:30 pm and every SATURDAY 8:00 am – 12:30 pm. The dates for large item clean up days will be **APRIL 24th, 2021 and SEPTEMBER 25th , 2021. Due to increasing prices at the landfill we will be increasing our prices for tires and other items. You can talk to Scotte Meyer at the Recycling Center. Please Recycle.**

Zoning-PERMITS are needed before Construction.

Contact Pete Strachan 608-689-2445 for a New Fire Number, New Driveway, or SITE PERMIT for Town of Harmony, local municipality zoning. Land being sold needs to be zoned appropriately before the sale if the land use is changing. Jim Theler is also available if you have zoning Questions 608-483-3288.

Contact Ashley Oliphant, Vernon County Sanitation @608-637-5271 for SANITATION PERMIT. Must have this before UDC building permit can be issued. If Water or Waste Water Plumbing inside home, must have a Private Onsite Waste Treatment System PERMIT.

Contact Vincent Schmitz 608-487-4642 for UDC Building PERMIT (Uniform Dwelling Code) from the State of Wisconsin. Under state statutes, every new dwelling has to be inspected.

Attention-Please be aware of the Townships right-of -way is 33 feet from center of road. Please do not destroy ditches, tubes or waterways, and Kindly remove vehicles, fences, tree's or other obstacles in the road right-of-way. Failure to comply will result in the Township billing property owners.
