Another year is almost past and we all know we love to receive our tax bills. Scotte and Steve are doing a great job please let them how you appreciate them and the work they do.

**Vernon County has contracted again with a mailing company to produce and distribute tax bills for the Township. The 1st installment of taxes is collected by the Township, payments need to be made payable to the Town of Harmony and mailed to, Town of Harmony, Attn: Carolyn Parr, S4102 County Rd O, Viroqua, WI 54665, or they may be put in the lock box at the Town Hall for the 1st half only. Do not mail to the Town Hall.**

**We have a new option this year to pay the 1st installment. You can pay by using a credit card. Instructions are: Go to <https://vernoncountywi.gov>, Click pay online, Guest Sign In, Click accept and sign in, Type in Parcel # or Last Name and First initial (do not do both), Check the parcel(s) you want to pay, Click add to cart, Add payment information and follow steps from there. There is a fee for E-Check \$1.50 fee or Credit Card 2.99% fee. If you have any questions, you can call the VC Treasurer office during business hours, 8:30-4:30, M-F at 608-637-5367.**

**If you are going to claim your taxes in 2025, payment must be postmarked by December 31, 2025. All other payments must be postmarked by January 31, 2026 to be considered timely by the county. Please make sure you pay the correct amount due. Tax roll copies will be available at Sorenson Lane, Town Hall or online. 2nd installment will be collected by the Vernon County Treasurer by check or credit card, not the Township Clerk.**

**Assessment questions need to be directed to Barrett Brenner, (715) 926-3199. Tax bill errors need to be addressed at the County Treasurer's office at 608-637-5367.**

Dog license fees may be mailed with tax payments. **ALL DOGS MUST HAVE A LICENSE.** They must be Paid by a separate check to Town of Harmony. Dog licenses are due by January 31 ,2026. Male \$8.00, Neutered \$3.00, Female \$8.00, Spayed \$3.00, Kennel licenses are \$35.00. Please enclose your current Rabies Certificate of Vaccination (NOT AN INVOICE) or I cannot issue a license. If you do not have a copy, you can mail original and I will make a copy and send original back to you.

**TOWN RECYCLING CENTER WILL BE OPEN TUESDAY'S 3:30 pm – 6:30 pm and SATURDAY'S 7:00 am – 12:00 pm. PLEASE ABIDE BY THESE HOURS, PLEASE DO NOT COME EARLY OR LATE OR DROP OFF AND LEAVE RECYCLES IF UNATTENDED.** The dates for large item clean up days will be first Saturday in April, 2026, and the last Saturday in September, 2026. Tires will be no longer be collected at the Recycling Center. Our price for garbage is \$60/ton, recycle items are free. Zoning Permits are needed before Construction. Contact Pete Strachan at 608-689-2445 for local municipality zoning, fire numbers, new driveways or site permits. Land being sold needs to be zoned appropriately, before the sale if land use is changing. Jim Theler is also available if you have zoning questions at 608-483-3288. Contact Matt Albrecht, Vernon County Sanitation at 608-637-5271 for SANITATION PERMIT. Must have this before UDC building permit can be issued. If Water or Waste Water Plumbing inside home, must have a Private Onsite Waste Treatment System Permit

General Engineering Company (GEC). They are our UDC Inspector for your UDC Building PERMIT (Uniform Dwelling Code) from the State of Wisconsin. You can call GEC, 608-745-4070. Under state statutes, every new dwelling must be inspected. They are also listed on our website.

Attention-Please be aware of the Township Road right-of-way. It is 33 feet from center of road. Please do not destroy ditches, tubes or waterways. Kindly remove vehicles, fences, trees/branches or other obstacles in the road right-of-way. Failure to comply will result in the Township billing property owners for removal.
